Dear Parent/Student,

In just a few short years of operation, the Student Pollworker Program in Riverside County has provided hundreds of students throughout the county with the opportunity to participate in the democratic process at its most fundamental level, the polling place. These students work alongside their adult Election Officer counterparts on an equal footing, putting in the same hours from 6:15 a.m. until 9:00 p.m., receiving the same stipend, attending the same training, and performing the same functions.

The Student Pollworker Program affords an opportunity for educators to offer “real world” learning experiences in the elections process. It is hoped that your student’s teacher will be able to identify a small number of about **5 to 10** students from their classes who meet the eligibility criteria and nominate them to serve as Student Pollworkers in upcoming elections. In order to serve as a Student Pollworker, the student must be 16 years of age or older on or before Election Day, be a high school student in good standing with at least a 2.5 GPA, and be a United States citizen or lawful permanent resident.

The Registrar of Voters has a great demand for Student Pollworkers with bilingual skills in the **Spanish, Tagalog, Korean, Chinese and Vietnamese** language. Bilingual Student Pollworkers assist limited English proficient voters at the polls to facilitate effective participation in elections.

If your student would like to be considered for the Student Pollworker Program for upcoming elections, a Nomination Form must be completed and returned via fax to (951) 486-7335, by email to rovweb@co.riverside.ca.us, or by mail to the Registrar of Voters office; 2724 Gateway Dr., Riverside, CA 92507. **Incomplete** nomination forms **will be rejected** or returned to the student for completion if time permits.
