Dear Voter:

We have received your Vote-by-Mail ballot for the November 3, 2020 Consolidated General Election; however, it is incomplete. **Your Return Envelope was not signed.** Enclosed is an Unsigned Ballot Statement to complete, sign, and return to us. A signature is required to process your Vote-by-Mail ballot (Elections Code 3011 (a)(2)). A postage paid envelope is enclosed for returning your statement.

**READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING THIS STATEMENT.  
FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.**

1. You did not sign your Vote-by-Mail ballot identification envelope. In order to ensure that your Vote-by-Mail ballot will be counted, an Unsigned Ballot Envelope Statement must be completed and returned as soon as possible, but **no later than 5:00 p.m. on December 1, 2020**, two days prior to certification of the election.
2. You must sign your name where specified on the Statement (Voter's Signature) and include your address.
3. Place your completed Statement into the enclosed postage paid envelope. Mail, deliver, or have your completed Statement delivered to the Registrar of Voters' office at 2720 Gateway Drive, Riverside, CA 92507.
4. If you do not wish to send your completed Statement by mail or have it delivered, you may submit your completed Statement by email at [rovweb@rivco.org](mailto:rovweb@rivco.org) or facsimile transmission at **(951) 486-7272**, or submit your completed Statement at any voter assistance center or ballot drop-off location in Riverside County before 8:00 p.m. on Election Day. A 24/7 secure drop box is also available at the Registrar of Voters' office.
