

INSTRUCTIONS FOR VOTING

*** * * Landowner Voter Basis * * ***

(E.C. § 10525, Water Code § 35000)

A Mailed Ballot Election is being conducted in your water district pursuant to procedures established by the California Elections Code and the California Water Code.

The enclosed ballot is your OFFICIAL BALLOT for the election. Polling places **WILL NOT** be established for this election.

To vote your ballot, follow the instructions printed at the top of the ballot. Return the ballot in the pre-addressed, postage paid identification envelope. Be sure to seal the envelope, and sign your own name.

NOTE: Since this is a LANDOWNER ELECTION, a residence address is not required, however, a signature is required. The envelope containing the voted ballot may be mailed or delivered to the Registrar of Voters at 2724 Gateway Drive, Riverside, CA 92507. Your **ballot must be received** at the Registrar of Voters Office no later than 8 p.m. on Election Day or be postmarked on or before Election Day and received no later than three days after Election Day to be counted.

INSTRUCTIONS TO VOTERS:

To vote for a candidate whose name appears on the ballot, mark a cross (X) in the voting square to the right of the candidate's name. In this election, two Directors are to be elected. Mark a cross (X) after the name of the candidate for whom you desire to vote, not to exceed the number that is to be elected.

To vote for a qualified write-in candidate, write the person's name in the blank space provided for that purpose after the names of the other candidates for the same office. Then mark a cross (X) in the voting square to the right of the write-in candidate.

All distinguishing marks or erasures are forbidden and make the ballot void.

If you wrongly mark, tear or deface this ballot, return it to the Riverside County Registrar of Voters and obtain another.

Separate the ballot (lower portion of this page) and place ballot in prepaid return envelope. Authorized voter **MUST SIGN** the return envelope or your ballot cannot be counted. Your ballot must be received at the Registrar of Voters office no later than 8 p.m. on Election Day or be postmarked on or before Election Day and received no later than three days after Election Day to be counted.
